Instructions for Requesting a Ballot Prior to Election Day:

Step 1. Complete the Ballot Selection Form. Your signature must appear on the form or you will not receive an absent voter ballot. Include contact information so we can reach you quickly if there is a signature verification issue.

Step 2. Deliver the form by one of the following methods. We **cannot** give a ballot to any person other than the voter, including a spouse or a family member.

- a) **By mail:** Place the completed form in an envelope addressed to the Unadilla Township Clerk and deposit it in the United States mail or with a delivery service. Proper postage is required if not using a prepaid envelope provided by your Clerk's office. You may also return the application by email to unadillatwp@yahoo.com as long as your signature is clearly visible.
- b) **In person:** Deliver the form personally to the Clerk's office located at Unadilla Township Hall, 126 Webb St, Gregory. If ballots are available, we will make every effort to issue one to you while you wait.
- c) **By a family member (certificate below is not needed):** In either (a) or (b), a member of the immediate family of the voter including a spouse, father-in-law, mother-in-law, brother-in-law, sister-in-law, son-in-law, daughter-in-law, grandparent, or grandchild or a person residing in the voter's household may mail or deliver the application to the Clerk for the applicant.
- d) **By a registered elector who fills out the certificate below:** If an applicant cannot return the application in any of the above methods, the applicant may select any registered elector to return the application. The person returning the application must sign and return the following:

Warning: You must be a United States citizen to vote. If you are not a United States citizen, you will not be issued an absent voter ballot. A person making a false statement in this absent voter ballot application is guilty of a misdemeanor. It is a violation of Michigan election law for a person other than those listed in the above instructions to return, offer to return, agree to return, or solicit to return your absent voter ballot application to the Clerk. An assistant authorized by the Clerk who receives absent voter ballot applications at a location other than the Clerk's office must have credentials signed by the Unadilla Township Clerk. Ask to see his or her credentials before entrusting your application with a person claiming to have the Clerk's authorization to return your application.
